**Conditions:**

1. The permittee shall notify any Fire Districts, the Highway Patrol, the Police Department, any School Districts, the Postal Service, and all utilities and newspapers affected by the closure, and shall comply with the requirements of the ordinance code of the City of Oakley, Title 10, and specifications relating thereto, and the policy on road closures.
2. All signing shall be in accordance with the most current edition of the State of California Manual of Traffic Controls.
3. The permittee shall notify all property owners affected by the road closure.
