

SUBJECT: Acceptance of work associated with CIP Project No. 77 – Citywide Street Name Sign Replacement Project

Background and Analysis

The City's adopted FY 2013/14 Capital Improvement Program (CIP) Budget designates funding for various infrastructure repair and replacement projects. This is consistent with the City's goals to improve the quality of the City's public infrastructure and to enhance the quality of life for our residents.

Capital Improvement Project No. 77 – Citywide Street Name Sign Replacement project removed and replaced the old existing street name signs, regulatory signs, and warning signs in various neighborhoods throughout the City. This project has replaced all street name signs in the last of the residential neighborhoods and the contractor finished the project on time and under budget. The neighborhoods that were included with this project were as follows:

- The subdivision that is bound by Oakley Road and Laurel Road between Live Oak Avenue and Empire Avenue including the Heather Park Subdivision located north of Oakley Road at Kelsey Lane
- 2) The subdivision east of Main Street between Honey Lane and Hill Avenue which includes the streets of Hill Avenue, Malicoat Avenue and Douglas Road
- 3) The entire subdivision south of Laurel Road and east of Marsh Creek
- 4) The western portion of the Summer Lake Subdivision; south of Cypress Road

Summary

Prior to construction, staff communicated the project with the residents who had sign posts in front of their property to inform them that new signs would be installed in the coming weeks. Contact information was also provided so that if any issues came up during construction they could be addressed expeditiously by staff and the construction team. This approach was particularly valuable during construction when new posts were installed near existing planter areas and irrigation systems so they would not be damaged.

The collaborative effort by the staff, residents, and contractor resulted in a better project and reduced some of the inconveniences that could have resulted from the project. The successful completion of this project also adds a new asset to the City of Oakley public infrastructure system.

Fiscal Impact

This construction contract awarded by the City Council was for \$61,731.00 with the contingency amount of \$7,000.00 bringing the total authorized budget to \$68,731.00. This construction contract was successfully completed under the authorized budget for \$61,053.00.

Pursuant to the contract documents, 5% of the accrued costs were withheld from the amount paid to the contractor. These funds are called "retention", and are held until the end of the project to ensure that the contractor completes the project in a timely manner. Approval of this item will authorize the release of the retention payment to the contractor. The retention was already budgeted as part of the contract and change order approvals, so there is no additional fiscal impact associated with this action.

Recommendation

Staff recommends that the City Council Adopt the Resolution accepting CIP Project No. 77 – Citywide Street Name Sign Replacement Project as constructed by Chrisp Company to be complete, and to direct the City Clerk to file a Notice of Completion for the project with the County Recorder.

WHEREAS, Chrisp Company has satisfied the contractual requirements necessary for the acceptance of CIP No. 77 as complete.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the City Council of the City of Oakley that CIP Project No. 77 – Citywide Street Name Sign Replacement Project is hereby accepted as complete

BE IT FURTHER RESOLVED AND ORDERED, that the City Clerk is hereby directed to file a Notice of Completion for CIP No. 77 with the County Recorder.
