SUBJECT: Acceptance of work with Yelton Demolition Company, Inc. for the demolition and disposal of the building located at 3510 Main Street associated with CIP Project No. 165 – Main Street Downtown Improvement Project

Background and Analysis

The City's adopted FY 2016/17 Capital Improvement Program (CIP) Budget designates funding for various infrastructure repair and replacement projects. This is consistent with the City's goals to improve the quality of the City's public infrastructure and to enhance the quality of life for our residents.

The Main Street Downtown Improvement Project is a multi-phase project that will improve and reconstruct downtown Oakley from Norcross Lane to Fifth Street.

This project includes the relocation of existing utilities, installation of a new storm drain system, construction of new curb, gutter, sidewalk, median, landscaping, decorative street lighting, signal upgrades at O'Hara and Main Street and the installation of a new traffic signal at Norcross Lane and Main Street.

Removal of a City owned building located at 3510 Main Street was required due to the alignment of the Main Street Downtown Improvement project. This was an old building that had passed its useful life and was in the path of the new street improvements, and needed to be demolished.

During the demolition, staff worked diligently with the contractor to minimize the impact and inconveniences to the neighbors and community. The demolition took less than 2 weeks to complete and the site has been cleared and ready for the downtown improvement project.

Fiscal Impact

This construction contract awarded by the City Council was for \$32,770.00 with a contingency amount of \$5,000, bringing the total authorized construction budget to \$37,770.00. This construction contract was successfully completed under the authorized budget of \$35,203.40.

Pursuant to the contract documents, 5% of the accrued costs were withheld from the amount paid to the contractor. These funds are called "retention", and are held until the end of the project to ensure that the contractor completes the project in a timely manner. Approval of this item will authorize the release of the retention payment to the contractor. The retention was already budgeted as part of the contract and change order approvals, so there is no additional fiscal impact associated with this action.

Staff Recommendation

Staff recommends that the City Council Adopt the Resolution accepting the demolition and disposal of the buildings located at 3510 Main Street associated with CIP Project No. 165 – Main Street Downtown Improvement Project as completed by Yelton Demolition Company, and to direct the City Clerk to file a Notice of Completion for the project with the County Recorder.

WHEREAS, Yelton Demolition Company, Inc. has satisfied the contractual requirements necessary for the acceptance of the demolition and disposal of the buildings at 3510 Main Street for the Main Street Downtown Improvement Project — CIP 165 as complete; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the City Council of the City of Oakley that the demolition and disposal of the buildings at 3510 Main Street for the Main Street Downtown Improvement Project – CIP 165 is hereby accepted as complete.
