Traffic Order Pertaining to Parking of Over-Height Trucks

#### FOR CONSIDERATION AT THE CITY COUNCIL MEETING ON FEBRUARY 14, 2017

#### **Background and Analysis**

The Oakley Municipal Code, Sec. 6.1.102 *et seq* allows the City Engineer to issue Traffic Orders for the regulation of traffic and parking. After approval of each Order by the City Council, signs are posted warning the public of the restriction or prohibition. Thereafter, citations can be issued for violators.

The City Engineer proposes to issue Traffic Order #17-01, attached hereto. We are experiencing the situation of large tractor trailer trucks being parked on streets, rather than in designated truck parking areas, thus causing a number of potential problems, including: blocking sight lines, interfering with turning movements, obstructing views of traffic control signs and devices, and becoming a visual blight. In areas where these situations occur, the City Engineer proposes to post signs prohibiting the parking of trucks over seven feet in height. Once signs are posted, any vehicles violating the prohibition could be cited by police or code enforcement officers.

#### Fiscal Impact

No negative impact; modest cost for sign placement; possible modest revenue from fines.

### Recommendation

Adopt the resolution approving the Traffic Order.

#### **TRAFFIC ORDER 17-01**

# **Prohibiting Parking of Over-Height Vehicles**

- A. Oakley Municipal Code Sec. 6.1.102 *et seq* permits the City Engineer to issue Traffic Orders to regulate various aspects of traffic movement and parking.
- B. This Order is issued pursuant to Municipal Code Sec. 6.1.104(a) (f) and (k).
- C. I find that the parking of over-height trucks on various City streets, instead of at designated truck parking lots, can block sight lines, interfere with turning movements, obstruct views of traffic control signs and devices, and be a visual blight on the community.
- D. From time to time, the undersigned will order that the parking of vehicles/trucks in excess of seven feet (7') in height on City streets or on private property open and available to public users be prohibited at all times. The locations of such locations shall be documented in writing, signed by the City Engineer, and filed with this Traffic Order.
- E. When this Traffic Order is approved by resolution adopted by the City Council, and when signs as required by the Vehicle Code are posted announcing such prohibition, this Traffic Order shall become fully effective. Vehicles parked in violation of this Traffic Order may be cited by police or code enforcement officers.
- F. Any property owner adversely affected by this Traffic Order may appeal to the City Council any designation of his/her property as being subject to this Order.
