Rosewood Subdivision 8787 Tentative Map Extension (TME 02-17) - A

request to extend the Tentative Map approval for an additional three

years.

## SUMMARY

This is a public hearing on a request by Monte Davis of Discovery Builders, Inc. ("Applicant") for approval of a Tentative Map Extension. The applicant is requesting to extend the approval of Tentative Map 8787 (known as "Rosewood Subdivision") for an additional three (3) years ("Project"). The approved Tentative Map consists of approximately 14 acres subdivided into 61 detached single family residential lots. The project is located at 4073 Rose Avenue and zoned R-6 (Single Family Residential District. APN 035-220-032.1

Staff recommends the City Council adopt the resolution approving Rosewood Subdivision 8787 Tentative Map Extension (TME 02-17), extending the Tentative Map approval for an additional three years, as conditioned.

#### **BACKGROUND**

### General Plan and Zoning

- The General Plan Land Use Designation for the project site is *Single Family Residential*, *High Density* ("SH") as depicted in the <u>Oakley 2020 General Plan</u> Figure 2-2 (Land Use Diagram).
- The site is zoned R-6 (Single Family Residential) District.

#### Previous Entitlements and Subdivision Extensions

On March 23, 2010, the City Council adopted the project's Mitigated Negative Declaration and Vesting Tentative Map 8787 through the adoption of Resolution No. 40-10. The Tentative Map received a three (3) year approval period from its approval date, and therefore, was set to expire on March 23, 2013. With the addition of state-wide automatic map extensions<sup>2</sup> the Tentative Map expiration date was extended for an additional four (4) years, or to March 23, 2017.

#### PROJECT DESCRIPTION

The applicant is requesting an extension of three (3) years to the entitlement. The approved Tentative Map consists of subdividing approximately 14 acres into 61 detached single family residential lots. The minimum lot size on the approved Tentative Map is 6,000 square feet, with an average lot size of 6,145 square feet. Gross density of the project, which includes all acreage prior to dedication of streets and other right of way, is 4.36 dwelling units per gross acre. The approved Tentative Map is included as an attachment to this Staff Report

## **ENVIRONMENTAL REVIEW**

It can be seen with certainty that the request for an extension to the Tentative Map will not result in any new physical impacts to the project, and therefore not result in any new significant environmental impacts. The project falls within the scope of the original California Environmental Quality Act ("CEQA") analysis and no further environmental analysis is required.

#### **ANALYSIS**

The Subdivision Map Act (Government Code 66452.6 (e)) allows the governing body with authority to approve a tentative map to extend that approval for a period not to exceed six (6) additional years from the original expiration date. That original expiration date would include any automatic extensions, such as those mentioned above, and the extension does not have to occur in one approval. In other words, the City Council may grant multiple approvals on the same map, so long as requests for extensions are submitted prior to expiration of the map, pursuant to the Subdivision Map Act.

The subdivision is located at the northwest corner of Laurel Road and Rose Avenue. It is surrounded by the Single Family Residential, Medium and High Density General Plan Land Use Designations to the north, east, and south, and by the Laurel Ball Fields to the west. The approved Duarte Ranch residential subdivision is located on the southeast corner of the same intersection. There have been no significant General Plan Land Use Amendments within the vicinity of the project since its adoption. Construction of the subdivision will result in beneficial improvements to Laurel Road and Rose Avenue.

This application is one of several recent extension requests by Discovery Builders, Inc. which owns several approved subdivisions within the City of Oakley. The developer has started proceeding with plans for construction of three subdivisions within Oakley, and requesting these extensions will ensure exiting entitlements do not expire.

## **Conditions of Approval**

Pursuant to the Subdivision Map Act, the City Council may approve or conditionally approve extensions to a tentative map. It is noted here and referenced in the proposed resolution's findings that all conditions of approval in Resolution No. 40-10 that are not modified in the proposed resolution are still in full effect for this Tentative Map. Revised conditions of approval are related to the expiration date of the Tentative Map, and updates to Public Works and Engineering requirements. All changes are included in the proposed resolution, which includes references to the condition of approval numbers in Resolution No. 40-10.

#### **FINDINGS**

Complete draft findings are included in the attached resolution.

### RECOMMENDATION

Staff recommends the City Council adopt the resolution approving Rosewood Subdivision 8787 Tentative Map Extension (TME 02-17), extending the Tentative Map approval for an additional three years, as conditioned.

Alternatively, the Council may wish to grant a lesser extension than the recommended three years, as there is no limit to how many applications for extension may be filed, only the total amount of extension time allow.



A RESOLUTION OF THE CITY OF OAKLEY CITY COUNCIL MAKING FINDINGS AND APPROVING A TENTATIVE MAP EXTENSION FOR THE PROJECT KNOWN AS ROSEWOOD SUBDIVISION 8787 TENTATIVE MAP EXTENSION (TME 02-17)

#### **FINDINGS**

WHEREAS, on January 18, 2017, Monte Davis of Discovery Builders, Inc. ("Applicant") filed an application requesting to extend the approval of Tentative Map 8787 (known as "Rosewood Subdivision") for an additional three (3) years ("Project"). The approved Tentative Map consists of approximately 14 acres subdivided into 61 detached single family residential lots. The project is located at 4073 Rose Avenue and zoned R-6 (Single Family Residential) District. APN 035-220-032; and

WHEREAS, on February 16, 2017, the project application was deemed complete per Government Code section 65920 et. seg; and

WHEREAS, the map is currently set to expire on March 23, 2017; and

WHEREAS, Rosewood Subdivision consists of approximately 14 acres subdivided into 61 detached single family residential lot; and

WHEREAS, the General Plan Land Use Designation for the project site is Single Family Residential, High Density (SH) as depicted in the Oakley 2020 General Plan Figure 2-2 (Land Use Diagram). The site is zoned R-6 (Single Family Residential) District; and

WHEREAS, on March 23, 2010, the City Council approved the project Tentative Map through adoption of City Council Resolution No. 40-10; and

WHEREAS, it can be seen with certainty that the request for an extension to the tentative map will not result in any new physical impacts to the project, and therefore not result in any new significant environmental impacts. The project falls within the scope of the original California Environmental Quality Act (CEQA) analysis and no further environmental analysis is required; and

WHEREAS, on February 16, 2017, the Notice of Public Hearing for the project was posted at Oakley City Hall located at 3231 Main Street, outside the gym at Delta Vista Middle School located at 4901 Frank Hengel Way, outside the library at Freedom High School located at 1050 Neroly Road, and at the project location, and mailed out to all owners of property within 500 feet of the project boundaries, outside agencies, and parties requesting such notice; and

WHEREAS, on February 18, 2017, the Notice of Public Hearing for the project was published in the Contra Costa Times; and

WHEREAS, on February 28, 2017, the City Council opened the public hearing and received a report from City Staff, oral and written testimony from the applicant and public, and deliberated on the project. At the conclusion of its deliberations, the City Council took a vote and adopted this resolution to approve the project, as revised by the City Council during its deliberations; and

WHEREAS, if any term, provision, or portion of these Findings or the application of these Findings to a particular situation is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions of these Findings, or their application to other actions related to the Project, shall continue in full force and effect unless amended or modified by the City; and

WHEREAS, these Findings are based on the City's General Plan, the City's Zoning and Subdivision Ordinances, the Subdivision Map Act, Vesting Tentative Map 8787, and the information submitted to the City Council at its <u>February 28, 2017</u> meeting, both written and oral, including oral information provided by the applicant, as reflected in the minutes of such meetings, together with the documents contained in the file for the Subdivision (hereafter the "Record").

**NOW, THEREFORE, BE IT RESOLVED THAT,** on the basis of the above Findings and the entire Record, the City Council makes the following additional findings in support of the recommended approvals:

- A. Regarding the application requesting approval of Rosewood Subdivision 8787 Tentative Map Extension (TME 02-17), the City Council finds that:
  - 1. The proposed tentative map extension does not modify any of the original Tentative Map's design, and therefore, all of the findings made on the original tentative map (City Council Resolution No. 40-10) are still valid and apply to this extension; and
  - 2. All conditions of approval in City Council Resolution No 40-10, not otherwise modified by this resolution, are still in effect; and
- B. The Project complies with Measure J Growth Management requirements.

**BE IT FURTHER RESOLVED THAT,** on the basis of the above Findings and the Record, the City Council approves the applicant's request for Rosewood Subdivision 8787 Tentative Map Extension (TME 02-17), subject to the following conditions:

THE FOLLOWING CONDITIONS OF APPROVAL SHALL BE SATISFIED PRIOR TO THE ISSUANCE OF A BUILDING PERMIT UNLESS OTHERWISE NOTED (BOLD CONDITIONS ADDED OR AMENDED AT PUBLIC HEARING):

## **Planning Department Conditions**

- 1. Applicant shall comply with the requirements of the Oakley Municipal Code and applicable Conditions of Approval from City Council Resolution No. 40-10. Any exceptions must be stipulated in these Conditions of Approval.
- 2. This approval shall extend the approval of the Tentative Map for a period of three (3) additional years, resulting in <u>Tentative Map 8787 expiring on March 23, 2020</u>, unless it is further extended pursuant to the Subdivision Map Act or other automatic extensions. This extension shall constitute three (3) years of the maximum six (6) years of discretionary extension(s) allowed under Government Code section 66452.6(e).
- 3. All conditions of approval shall be satisfied by the owner/developer. All costs associated with compliance with the conditions shall be at the owner/developer's expense.
- 4. The applicant shall indemnify, defend, and hold harmless the City of Oakley, the City Approving Authorities, and the officers, agents, and employees of the City from any and all claims, damages and liability (including, but not limited to, damages, attorney fees, expenses of litigation, costs of court).

## **Public Works and Engineering Conditions**

- 5. Regarding annexation into Community Facilities Districts, Condition of Approval Nos. 87, 88, 89 and 91 of City Council Resolution No. 40-10 shall be replaced with the following condition:
  - a. Prior to filing a final map, the Applicant shall annex the property to the City of Oakley Community Facilities District No. 2015-2 which provides a funding mechanism to mitigate the Development's fiscal impact associated with the City's regional, community and neighborhood parks, public area landscaping, street lights and storm water facilities. The Applicant shall apply for annexation and provide all information and documents required by the City or its agents in processing the annexation. All costs of annexation shall be paid by Applicant.
- 6. Regarding Street Lights, Condition of Approval No. 60 from City Council Resolution No. 40-10 shall be revised as follows:
  - a. Install streetlights along all project streets and the project Laurel Road and Rose Avenue frontages. The City Engineer shall determine the final number and location of the lights, and the lights shall be on an LS2-A rate service. The lights on the project streets and Rose Avenue shall be LEDs and decorative per City standards. The lights along Laurel Road shall be LEDs and spun aluminum "cobra heads" style per City standards.

- 7. Regarding Landscaping, Street Lights, Condition of Approval No. 83 from City Council Resolution No. 40-10 shall be revised as follows:
  - a. Maintain all landscaping within the public right of way until such time that the adjacent roadway improvements have been accepted for maintenance. City shall reasonably consider partial acceptance of landscape and roadway improvements subject to improvements being complete, landscaping passing the required plant establishment period, and adequate funds being available from the City of Oakley Community Facilities District No. 2015-2 to operate and maintain the landscaping being accepted.
