Grant Application

Background

The Contra Costa Water District (CCWD) is leading a number of other public agencies to expand the Los Vaqueros Reservoir. The recent drought helped many realize the need to increase water storage and Los Vaqueros has been an unquestioned success. There is capacity to expand the Reservoir and funding is available through the State's Proposition 1 program. Dear Chair Quintero:

The City Council of the City of Oakley is writing to express its strong support for the Water Supply Investment Program funding application submitted for Proposition 1 funding for the Los Vaqueros Reservoir Expansion Project.

In 2014, California voters approved \$2.7 billion in funding for water storage projects as part of Proposition 1: the Water Quality, Supply and Infrastructure Act of 2014. The approval by voters signaled that they understand the importance of water storage and are willing to fund construction projects. The recent drought followed by the wettest year on record only further highlighted the state-wide need for more storage to prepare for drought and flood emergencies.

Los Vaqueros Reservoir is an off-stream reservoir in Brentwood, with fully-screened Delta intakes, that has the potential to provide multiple public benefits that qualify for Proposition 1 funding. Public benefits of this project include: supply for South-of-Delta wildlife refuges; drought and emergency preparedness; statewide integration potential; protection of water quality; and recreation enhancement.

Expanding Los Vaqueros Reservoir is a project that embodies what the voters approved when they passed Proposition 1. This is a forward-thinking project, operating surface storage in a unique way for regional and environmental benefits.

We appreciate the California Water Commission's consideration of this important project and encourage the Commission to approve the Proposition 1 funding application.



HOW IT WORKS

Water is pumped into the system from one of four existing Delta Intakes.

Once in the system, water is sent to an upgraded Transfer Facility.

From the Transfer Facility, water can be delivered directly to partner agencies or stored in an expanded Los Vaqueros Reservoir for later delivery.



FUNDING

Estimated project cost:

\$800 Million

 Prop. 1 funding could pay for the public benefits of Los Vaqueros Reservoir Expansion Project

PROP 1 PUBLIC BENEFIT CATEGORIES

- Ecosystem improvement
- Emergency response
- · Water quality improvement · Recreation

 Up to 50% of project cost may be paid for by California Proposition 1

50% = Prop 1

 Remainder of project cost would be covered by partner agencies










POTENTIAL PARTNERS
