Background and Analysis

The Contra Costa Transportation Authority (CCTA) is a public agency formed by Contra Costa County voters in 1988 to manage the County's transportation sales tax program and to do countywide transportation planning.

The CCTA has a Citizens Advisory Committee (CAC) to provide citizen perspective, participation and involvement. The CAC is made up of 23 members, 20 members appointed by Contra Costa cities (including Oakley), towns and the County and 3 "at-large" members.

The term for Oakley's current appointee to the CAC expires this week. Staff advertised for and received applications for the next four-year term. Staff encouraged applicants to attend the meeting this evening to be interviewed.

Fiscal Impact

Recommendation

Staff recommends the City Council review the applications and adopt the attached resolution to appoint a representative to the CCTA-CAC to represent the City of Oakley for the next four-year term beginning August 12, 2017. The CAC does not allow alternate representatives.

Background Information

The Contra Costa Transportation Authority (CCTA) maintains a standing Citizens Advisory Committee (CAC) to provide citizen perspective, participation and involvement in the CCTA's Transportation Expenditure Plan and Growth Management Program. The CAC is comprised of 23 members: 20 are appointed by each of the 20 local jurisdictions within Contra Costa (the cities, towns and the County); three "at-large" members who should be residents of Contra Costa and are nominated by community-based stakeholder organizations within Contra Costa, and subsequently appointed to the CAC by CCTA.

To become a member of the CAC, you must reside within the City of Oakley and the Oakley City Council must take formal action to confirm your membership on the Committee. Appointees serve at the will and pleasure of the Oakley City Council and are required to provide the Oakley City Council quarterly updates, preferably at its Council meetings.

CAC members are appointed to serve for a four-year term (the next term commencing August 12, 2017) without compensation from either the CCTA or the City of Oakley. Members will, however, receive reimbursement from the CCTA for travel expenses to and from the CAC meetings. SUMMARY:

A self-motivated, quick learning, team oriented Environmental Health and Safety Engineer Associate/ Principal Radiation Control Technician with more than thirty-seven years of commercial nuclear power and R&D facility experience. Major strengths in quickly learning new skills, jobs, technologies and concepts, identifying and solving radiological problems, effectively directing and controlling workers in radiologically controlled areas. Additional skills in trouble shooting, repairing, building/modifying, calibrating Health Physics Instruments, procedure writing, Decontamination and Demolition Planning, conducting Emergency Plan drills and exercises, scenario development/writing, planning and staffing.

ACCOMPLISHMENTS:

Lawrence Berkeley National Laboratory: Identified all of the buildings onsite, which were suspected to or contained legacy radioactive materials. Developed a map of the site with all of the buildings with legacy and active radiological concerns. Developed and implemented a plan for performing a legacy radioactive materials survey sweep of the lab. Developed a searchable knowledge database for all of the legacy radioactive materials buildings. Designed and assisted in developing an ACCESS database survey documentation system and search engine to improve detail and the quality of documentation and provide quicker and more accurate service to our Facilities service groups.

Prior to the closure of Rancho Seco a feasibility study was initiated for cost effectiveness but was canceled due to plant closure. Initiated a system for emergency planning scenario development and implementation using WordPerfect 5.0, Micro Soft Excel and Formbase programs that reduced paper work, person-hours and increased the efficiency of record keeping.

I believe that my experience and qualifications would be highly beneficial to the Committee to support its purpose of providing citizen perspective, participation and involvement in Authority policy development and implementation. I have taken time to identify and educate myself on transportation issues of regional, countywide, and local concern. I have read Plan Bay Area 2040 published this year by the Metropolitan Planning Commission which covers the transportation goals and objectives for the 9 Bay Area Counties for the next 24 years. I have also read the Draft 2017 Comprehensive Transportation Plan published by the Contra Costa Transportation Authority which spells out the Vision of (1) a balanced, safe, and efficient transportation network, (2) cooperative planning, and (3) growth management that is supported by Goals and Strategies. I reviewed the 2015 East County Action Plan for Routes of Regional Significance that was published by TRANSPLAN and CCTA that details Oakley's Routes of Regional Significance. To support these policies, I have nearly 40 years of experience in Silicon Valley in the areas of manufacturing finance and materials management. My experience in manufacturing finance includes project accounting that reported and managed costs, cost accounting, financial planning and analysis, and controllership in small telecommunications company. For

materials management, I worked in project management at a distributor and as a supply chain manager at a large electronics manufacturing services provider. Both the distributor and the EMS provider used matrix management which required cross-functional teams. This compelled collaborative interpersonal skills in dealing with people outside of your area of expertise which would be valuable to the CAC. I have also been a law clerk for 2 law firms while I was attending law school. While in military service, I served as a liaison officer, platoon leader and assistant Battalion S-3.

8. What do you feel are the most pressing matters for the Contra Costa Transportation Authority and what would you suggest to resolve those matters?

I think the most immediate and pressing problem for the Contra Costa Transportation Authority is traffic congestion particularly during commute hour. County traffic congestion particularly impacts SR-4, Vasco Road, I-680, and I-80. It is a pressing matter because traffic congestion creates wear and tear on the pavement. As the pavement degrades through the increased traffic flow, funds are required to maintain and if necessary repair. In addition to maintaining our current roads, we must build roadways and transit systems now to prevent and mitigate the increased volume from future population growth. My suggestion is that we have to plan for the growth and implement steps to mitigate the impact of that growth that will not only impact traffic but our quality of life. Fortunately, with the passage of Measure C in 1988 and Measure J in 2004 which extends the half cent sales tax to 2034, Contra Costa County has the funding and the framework necessary to manage the impact of traffic growth. In order for local jurisdictions to receive Measure J funds for Local street maintenance and improvement plus transportation for livable communities, they must adopt a Growth Management Plan (GMP). The GMP requires that each local jurisdiction adopts such items as a Growth Management Element, participate in an Ongoing Cooperative, Multi-Jurisdictional Planning processes like a Regional Transportation Planning Committee (RTPC), address housing options and requires a voter approved urban limit line. The RTPCs

(West, Central, East, Lamorinda, and the Tri-Valley) are key to building a consensus within the County on what the priorities are for roadway maintenance should be for our County. Each RTPC prepares an Action Plan for Routes of Regional Significance that will be knitted into the CCTA Comprehensive

Transportation Plan(CTP). Once the Action Plans with their goals are agreed upon by the RTPC and

CCTA, then they will be monitored by Multi-modal Transportation Service Objectives (MTSO). There are projects, programs, measures and actions that will support the MTSO's. The East County RTPC

(TRANSPLAN) has 5 goals and 5 MTSOs. Some of the goals are the following: Maintain or Improve

Efficiency of Freeway and Arterial Operations; Support an Efficient and Effective Transit System; and

Manage the Effects of New Growth on the Transportation System. Some MTSO's are Delay Index and

Roadway Segment Level of Service. I believe that these proactive measures by the TRANSPLAN RTPC

will help resolve future traffic congestion for Oakley residents.

Briefly describe your interest in serving on the Citizens Advisory Committee, citing any relevant volunteer or work experience.

As someone who grew up in the Santa Clara Valley in the 1950's and 1960's, I know how unplanned growth can impact your quality of life. The Valley went from agricultural to industrial within a period of 20 years. Traffic increased exponentially, housing prices skyrocketed and the cost of living was prohibited to families with modest means. Unfortunately, those same issues are impacting Contra Costa County. However, the MTC Plan Bay Area 2040 and the CCTA Draft 2017 Comprehensive Transportation Plan lays out a framework that will prevent unplanned growth in the County. I want to use my nearly 40 years of finance and materials experience in the Silicon Valley to assist in implementing the Transportation Vision in the CTP.
