#### 1-1.17 HOT MIX ASPHALT (HMA)

#### GENERAL

Do not leave a vertical joint more than 0.15 foot high between adjacent lanes open to public traffic. Place W8-17 signs adjacent to the traveled way's outside edge. Place the first W8-17 sign where the vertical joint begins in the direction of travel on that lane. Place the W8-17 signs at 1,000 foot maximum intervals and at ramps and public roads entering the traffic lane.

The contract price paid per ton for "Hot Mix Asphalt Overlay (3.5 Inches)" shall include full compensation for furnishing all labor, materials, temporary tapers, tools, equipment, and incidentals, and for doing all the work involved in HMA, complete in place, including surface preparation, tack coat, preparation, submission and verification testing costs for the JMF; providing the Contractor's Quality Control Plan; and the costs of coring to verify core densities if required, as shown on the plans, as specified in the Standard Specification and these special provisions, and as directed by the Engineer. Contractor shall provide certification of compliance and delivery manifest when asphalt is placed.

The contract price paid per ton for "Hot Mix Asphalt Overlay (6 Inches)" in Bid Alternate 1 shall include full compensation for furnishing all labor, materials, temporary tapers, tools, equipment, and incidentals, and for doing all the work involved in HMA, complete in place, including surface preparation, tack coat, preparation, submission and verification testing costs for the JMF; providing the Contractor's Quality Control Plan; and the costs of coring to verify core densities if required, as shown on the plans, as specified in the Standard Specification and these special provisions, and as directed by the Engineer. Contractor shall provide certification of compliance and delivery manifest when asphalt is placed.

The contract price paid per ton for "Hot Mix Asphalt Overlay (4.5 Inches)" in Bid Alternate 2 shall include full compensation for furnishing all labor, materials, temporary tapers, tools, equipment, and incidentals, and for doing all the work involved in HMA, complete in place, including surface preparation, tack coat, preparation, submission and verification testing costs for the JMF; providing the Contractor's Quality Control Plan; and the costs of coring to verify core densities if required, as shown on the plans, as specified in the Standard Specification and these special provisions, and as directed by the Engineer. Contractor shall provide certification of compliance and delivery manifest when asphalt is placed.

#### 1-1.18 RUBBERIZED HOT-MIX ASPHALT

#### MEASUREMENT AND PAYMENT

The contract price paid per ton for "Rubberized Hot Mix Asphalt Overlay (2.5-inches)" shall include full compensation for furnishing all labor, materials, temporary tapers, tools, equipment, and incidentals and doing all work involved in constructing asphalt concrete, including mix design preparation, contractor quality control according to Section 39, "Hot Mix Asphalt," of the Standard Specifications, quality control plan and quality control testing and reporting, complete in place, as shown on the plans and as specified in the Standard Specifications and these Special Provisions or as directed by the Engineer.

All bidders shall acknowledge receipt and acceptance of Addendum No. 3 by signing in the space provided at the end of this Addendum and submitting the signed addendum with their proposal.
