II. Updates to the Part III of the Specifications:

1. Replace 2nd paragraph language in Section 10-1.16 EARTHWORK under GENERAL heading with the following:

Earthwork shall conform to the Project Geotechnical Report included in Appendix A prepared by Cal Engineering and Geology dated March 30, 2022 – Geotechnical Design Report – East Cypress Road Widening Project, and to the provisions in Section 19, "Earthwork," of the Standard Specifications and these technical specifications.

2. Replace 2nd paragraph language in Section 10-1.16 EARTHWORK under Materials, General subsection with the following:

General

Excavated material that is suitable for fill construction shall be conditioned for reuse and properly stockpiled for later filling and backfilling operations. Conditioning shall consist of spreading material in layers not to exceed 8 inches and raking free of debris and rubble. Rocks exceeding 3 inches in largest dimension, unsuitable material and deleterious material shall be removed from the site and disposed of as specified herein under Disposal of Surplus Material.

3. Delete the language in Section 10-1.16 EARTHWORK under Materials, Fill and Backfill subsection and replace with the following:

Fill and Backfill

Well-to moderately well-graded soils consisting of sands, silts, and clays, with or without gravel, as excavated, screened or blended, having the following mechanical properties and gradation:

1. Gradation (ASTM D422)

Sieve Opening	Percent Passing by Weight
6-inch Square	100
3/4 -inch Square	70 min

- 2. Liquid Limit (ASTM D4318): 50 max
- 3. Plasticity Limit (ASTM D4318): 25 max

4. Replace the following Pay Clause in Section 10-1.29 – Sanitary Sewer Force Main Improvements under Measurement and Payment

VERTICAL OFFSET ON SEWER FORCE MAIN PIPE shall be at the cost indicated in the Bid Schedule. The contract lumpsum price paid for VERTICAL OFFSET ON SEWER FORCE MAIN PIPE shall include, but is not limited to, full compensation for furnishing all labor, materials, tools, equipment and incidentals required for doing all the work involved with installing new 14" PVC C900 DR14 sewer force main with horizontal and vertical bends around the proposed storm drainage main, maintain existing sanitary sewer flows during construction, optional sewer bypass to Bethel Island Road and East Cypress Road intersection northwest corner, sewer bypass discharge and clean up fees and coordination with Ironhouse Sanitary District for sewer bypass, trenching and excavation, over excavation, dewatering, bedding, coarse bedding material in geotextile wrap with 12 min. overlap at fabric edges, backfill, warning tape, submitting compaction reports, thrust blocks and mechanical restraints, and pavement restoration to finish grade, as shown on the Plans, as specified in the Standard Specifications, these Technical Specifications and the Special Provisions, and as directed by the Engineer. Additionally, no payment will be made for work, equipment, or materials not covered in these plans and specifications, but necessary to insure a completed project as specified.

III. Updates to the Plan Sheets:

1. Replace Detail 7 on Sheet 10, G1.9 with the following
