Just because buildings at the Oaks are subsidized for low and fixed incomes no one should be subjected to the seriously foul living conditions there. As seen in Building 59, the roach infestation in 53 indicates a serious lack of concern by the owners enjoying the fruits of their exploitative investments.

City Code enforcement was notified. But this time they did nothing other than tell Black residents they only saw one roach and therefore there wasn't a problem. And they've not returned since. I've observed many cockroaches in those buildings. Maintenance has done nothing to fix cracks and holes in walls. The halls are filthy. The stairwells are filthy.

The state has inspected the site and determined there is a roach infestation. A report is forthcoming. All of those buildings should be evacuated, residents relocated, the buildings fumigated and professionally decontaminated at the owner's expense. That place needs to be shut down.
